Pensana Rare Earths Plc (ASX: Pensana Rare Earths) – Admission and Commencement of Official Quotation

Description

On 1 November 2019, Pensana Metals Limited ('Pensana Metals') announced that it had entered into a scheme implementation agreement with Pensana Rare Earths Plc ('Pensana Rare Earths'), a public limited company incorporated in the United Kingdom for the sole purpose to effect a proposed re-domicile of Pensana Metals from Australia to the United Kingdom pursuant to a scheme of arrangement in accordance with Part 5.1 of the Corporations Act ('Scheme').

Under the Scheme, Pensana Metals' existing shareholders will have their shares transferred to Pensana Rare Earths by order of the Supreme Court of Western Australia ('Court'), and in exchange will receive one share to be settled in the form of a CHESS Depository Interest ('CDI') in Pensana Rare Earths as at the record date of the Scheme.

On 23 January 2020, Pensana Metals announced that the Court has made orders approving the Scheme and that the effective date of the Scheme is 23 January 2020.

On 7 February 2020, Pensana Rare Earths confirmed that all conditions of the Scheme have been satisfied.

Pensana Rare Earths was admitted to the Official List of ASX Limited ('ASX') today, on Friday, 7 February 2020.

Official quotation of Pensana Rare Earths' CHESS Depositary Interests ('CDIs') representing fully paid ordinary shares at a ratio of 1:1 is expected to commence at 10:06:45 AM +/- 15 seconds (AEDT) as part of Group 4 on Wednesday, 12 February 2020.
