

Conversion of Convertible Notes

10 March 2020

New Energy Minerals Limited (“**New Energy**”, the “**Company**”) (**ASX:NXE FRA:GGY**) announces the extension of the Convertible Note Agreements of 12 June 2019.

On 12 June 2019 the Company announced that it had secured short-term funding from sophisticated and professional investors in the form of unsecured convertible notes totalling A\$406,000 as amended on 10 December 2019.¹

The Company has agreed to the conversion of A\$42,000 (42,000 notes at a face value of A\$1.00) at a reduced conversion price of \$0.009 resulting in the issue of 4,666,667 new ordinary shares and the reduction of the Company’s liabilities by A\$42,000. Aside from the conversion of these notes the Conversion price for all remaining notes will remain at A\$0.022.
