Mr Watt was co-founder of Invisic (an Australian software business selling professional services automation) where he raised venture capital, expanded to the US and the UK (with offices in Australia), growing to over 100 people based in Seattle. Invisic was successfully sold in a trade sale. He is Chairman of Belengo, a flexible transport solutions tech business. Steve is currently based in Sydney but will move to MedAdvisor's Boston office in April 2020.

"I'm excited to be joining MedAdvisor to help accelerate the growth of the company," said **Steve Watt, CRO**. "The company has an outstanding team, market-leading



technology, and the support of a passionate, fast-growing customer base. From the outset, I was attracted to the company's strong vision and success as an innovator in the fast-growing tech health market, and I am looking forward to helping MedAdvisor further scale the business."
