FOD makes first hand sanitiser delivery; commences disinfectant production

Highlights

- **FOD has commenced first deliveries of hand sanitiser order to high priority clients including hospitals, schools and pharmacies**
- **In addition, further hand sanitiser orders from major supermarkets of over \$2.4million already received by Careline on behalf of FOD**
- **Initial order of \$2 million exceeded with just two customers with further orders growing rapidly**
- **FOD will also commence production of an all-purpose disinfectant – an ethanol-based product which is a powerful disinfectant on surfaces such as bathrooms and workspaces**
- **Disinfectant needed for widespread distribution to help combat spread of Coronavirus**
- **FOD has the capacity to produce disinfectant in large quantities and expects significant demand.**

The Food Revolution Group Limited (ASX:FOD) has delivered its first batch of hand sanitiser to the market this week. The product is in high demand due to the global outbreak of Coronavirus.

FOD has prioritised delivery of hand sanitiser products to hospitals, school colleges and pharmacies but has received strong demand from the major supermarket chains. Deliveries to these retailers is being scheduled for later this month. Currently, just these orders exceed \$2.4million.

Chairman Norman Li said, “Demand for our hand sanitiser product is far exceeding supply, but we have been fortunate enough with our extensive networks to procure the packaging we needed to deliver our first batch of the product as quickly as possible. We have prioritised those in most need and we will then deliver into the wider market to retailers such as supermarket chains.”

The company decided to market its hand sanitiser product under the “Care Touch” brand owned by its distribution partner Careline Pty Ltd, reserving the “Sanicare” brand for its new range of disinfectants. It will commence production of an all-purpose disinfectant under the Sanicare brand at its Mill Park Factory. The ethanol-based Sanicare product is a powerful disinfectant for use on counters, toilets, office and reception desks, railings or even laptops or mobile phones.

The anti-bacterial properties of this ethanol-based product mean it is effective for disinfecting surfaces such as wood, plastic and glass. The quick evaporation means that it leaves no residue behind. The denatured component of ethanol means it prevents bacteria growing and kills the present bacteria.

Dr Li commented, “This is the next product needed for widespread distribution to help combat the Coronavirus epidemic. FOD has the capacity to produce this product in large quantities and we expect a big demand for this product given recent enquiries from our customers.”
