# Covid-19 update

Bass Metals Limited (ASX: BSM) (**Bass** or the **Company**) provides the following update regarding its 100% owned Graphmada large flake graphite Mining Complex in Eastern Madagascar.

On Friday March 20<sup>th</sup> the Government of Madagascar announced the suspension of all inbound and outbound travel as it seeks to insulate Madagascar from the effects CoVID-19. Madagascar currently has under 5 reported cases, all of which appear to have resulted from inbound travel.

Bass has now repatriated all expatriate staff from Madagascar and put in place measures at Graphmada to ensure the health and safety of local staff.

Bass has previously advised (Bass Metals Strategic Update)<sup>1</sup>, that it had initiated a pause in mining and processing activities during the current monsoon season in Madagascar, with operations to recommence in April 2020.

Given the current uncertainty, the Board of Directors together with Senior Management have made the decision to suspend mining and processing and place the operations on a care and maintenance basis until some clarity in the current situation emerges.

Bass is able to continue its current exploration program at Graphmada as well as continue to progress its Feasibility Studies for the next stage of Graphmada operations.

Bass will provide an investor update shortly.
