Commonwealth Ombudsman selects archTIS' Kojensi platform to secure PROTECTED government-wide investigations

- The Commonwealth Ombudsman has purchased an initial 50 licenses of Kojensi in order to conduct investigations with agencies needing to share and collaborate on information classified up to PROTECTED.
- The Commonwealth Ombudsman safeguards the community in its dealings with the Australian Government and is responsible for inspecting the actions of authorities such as commonwealth, state and territory law enforcement agencies, state government departments, prisons, hospitals, schools, local government and public universities.
- The Commonwealth Ombudsman will use the Kojensi Platform as a PROTECTED service saving it a substantial cost in implementing an independent PROTECTED environment to meet its needs for hosting classified information.
- This sale continues archTIS' strong path to commercialisation of the Kojensi Platform and comes after a one month trial with the Ombudsman. The Commonwealth Ombudsman will provide external agencies working with them, the required licenses to unlock the full collaboration features of Kojensi, providing a growth path for Kojensi licenses.
- This Agreement will facilitate greater information sharing with other government departments and agencies who work with the Commonwealth Ombudsman.
- The current extended environment of worker self-isolation provides the company with an incredible opportunity to fast-track the uptake of its secure collaboration platform via its cloud infrastructure.

archTIS bring on Commonwealth Ombudsman as Kojensi client

The Commonwealth Ombudsman has purchased licenses for use of Kojensi, to facilitate a more secure way of conducting investigations and collaboration between agencies where security is a priority. The agreement includes an initial 12-month contract worth a minimum of \$35,454 in annual recurring revenue with two one-year extensions - with the ability for licenses to grow on a monthly basis. The agency will use Kojensi to conduct investigations with agencies housing PROTECTED information.

About the Commonwealth Ombudsman

The Commonwealth Ombudsman resolve complaints made between people and government, involving investigations into different agencies on both unclassified and classified information. Over 500,000 complaints are made to the public sector each year¹.

The Commonwealth Ombudsman has selected the Kojensi platform as a cost-effective solution to both conduct sensitive investigations and secure PROTECTED information in compliance with Commonwealth security requirements. This realises significant savings for the Ombudsman who would otherwise have to establish their own PROTECTED infrastructure at great expense.

Agreement provides exposure throughout government agencies working at PROTECTED

This announcement is important for archTIS as it provides exposure throughout each of the agencies the Commonwealth Ombudsman works with.

Daniel Lai, archTIS CEO, said: *"Currently these agencies are using USBs and safehand delivery to share documents and data required for these investigations. This has become more difficult in the current environment of self-isolation. This will completely change the way agencies work with the Commonwealth Ombudsman, improving both security and productivity. It is clear that those agencies that take security and privacy seriously understand the competitive advantage and cost effectiveness that Kojensi provides for their agency. I have no doubt that other agencies that do not want the expense of implementing a PROTECTED environment will also see our Kojensi Platform as an attractive alternative for corroboration on classified and sensitive material."*
