- Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: No. As per our announcement to the market on the 25 March 2020, Ensurance recently announced the sale of its non-core Australian underwriting business. This will result in immediate cost savings and increase net cash available from its core business.

- Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: As above. As per our announcement to the market on the 25 March 2020, non-core Australian underwriting business sold, which will bring in \$1.1m, less costs associated with the disposal, in addition to the cost savings.

- Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes. Core business is continuing to see significant growth. Disposal of non-core business generates additional cash to fund core business, cut unnecessary costs and focus management time into profitable areas.
