

COMPLETION OF AUSTRALIAN INSTITUTIONAL PLACEMENT

Salt Lake Potash Limited (SO4 or Company) is pleased to advise that it has completed the previously announced placement to a number of existing and new institutional shareholders and investors for the ongoing development of the Lake Way Project (Project).

The Placement of approximately 58.8 million shares at A\$0.34 each to raise A\$20.0 million before costs (Placement), further strengthens SO4's share register with strong demand from existing institutional shareholders.

Placement funds will enable SO4 to continue to deliver the Lake Way Project to schedule, with commissioning expected to commence in December 2020 and first production in Q1 2021.

The Institutional Placement, comprising 56,067,647 shares completed today. An additional 2,755,883 shares that Directors intend to subscribe for will be issued subject to shareholder approval. This includes 2,250,000 shares by Chairman, Mr Ian Middlemas and 505,883 shares by Managing Director and CEO, Mr Tony Swiericzuk. A notice of meeting will be sent to shareholders in due course.
