1. Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?	
Answer: No. Net operating cash outflows are expected to fall substantially following the completion of drilling activity at the entity's primary operation, the Misima Gold Project, in late March as a result of COVID-19 related travel restrictions, as well as additional cost reduction measures implemented by the entity in response to the COVID-19 impact on operations.	
2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?	
Answer: As noted in 8.8.1 expenditure rates are expected to fall substantially going forward, however, the entity will continue to monitor capital markets and if considered necessary, it would propose to raise further equity capital. Success is considered highly likely given a track record of successful capital raisings in recent years and strong ongoing support from major shareholders.	
3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?	

Answer: Yes, the entity can expect to be able to continue operations on the basis that expenditure levels have been significantly reduced and that, as noted in 8.8.2., the entity can raise additional equity if necessary.
