As described on the announcement on 14 January 2020, Titan Minerals Limited was successful in its offer to purchase all of the issued and outstanding common shares of Core Gold Inc, having acquired 91% as at the date of this report. The transaction was assessed by management and considered a reverse acquisition as described in AASB 3, under which for accounting purposes Titan Minerals Limited (legal parent) is the acquiree and Core Gold Inc. (legal subsidiary) is the acquirer. As required under AASB 3, following a reverse acquisition consolidated financial statements are issued under the name of the legal parent but described as a continuation of the financial statements of the legal subsidiary.

The cash flows for the quarter ending 31 March 2020 include cash flows of Core Gold Inc. for the entire quarter, and cash flows of Titan Minerals Limited from the acquisition date of the reverse acquisition.
