HIGHLIGHTS

Audalia Resources Limited (ASX: ACP) is pleased to present its report for the March 2020 quarter.

MEDCALF PROJECT

The Medcalf Project is a vanadium-titanium-iron project located some 470 kilometres south east of Perth near Lake Johnston, Western Australia. The Medcalf Project comprises three granted Exploration Licences E63/1133, E63/1134 and E63/1855 as well as mining lease M63/656 and miscellaneous licence L63/75. Together, these licences cover a total area of 38 km².

The Medcalf Project lies in the southern end of the Archaean Lake Johnston greenstone belt. This greenstone belt is a narrow, northnorthwest trending belt approximately 110 km in length. It is located near the south margin of the Yilgarn Craton, midway between the southern ends of the Norseman-Wiluna and the Forrestania-Southern Cross greenstone belts.




Figure 1: Medcalf Project - Location Map

Environmental Approval

During the quarter, Audalia and its environmental consultants continued to progress the studies required to support the Environmental Review Document (**ERD**) for the Medcalf Project. Most of the studies required by the approved Environmental Scoping Document have been completed. The ERD document is being finalised by the environmental consultant. The Company is planning to submit the ERD to the Environmental Protection Authority in the fourth quarter of the financial year ending 30 June 2020 (**Q4 FY20**).



Metallurgical Test Work

No progress was reported on the metallurgical test work being undertaken by Guangzhou Research Institute of Non-ferrous Metals (GZRINM) due to the Chinese New Year Holiday and the COVID-19 pandemic.

CORPORATE MATTERS

The Company had cash and cash equivalents as at 31 March 2020 of \$204,000 (Q2: \$342,000) following payments for capitalised exploration and evaluation expenditure of \$423,000 (Q2: \$1,285,000) and payments to related parties and their associates of \$35,000 (Q2: \$61,000) during the March 2020 quarter.

In March 2020, the Company issued 30,000,000 fully paid ordinary shares at an issue price of \$0.012 per share to a sophisticated investor raising \$360,000, before costs (**Placement**). The funds raised from the Placement will be used to progress the exploration and evaluation work at the Medcalf Project and to supplement general working capital.

The Company acknowledges its cash position at the end of the quarter and its estimated cash available for future operating activities. The Directors continue to assess funding alternatives to ensure the Company can continue exploration and evaluation activities at the Medcalf Project.

Answer:

Audalia is in the exploration and evaluation phase of its flagship Medcalf Project and as a result, expects to have negative operating cash flows for the time being.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer:

Audalia manages its cash flow through ongoing budgeting, forecasting and financial reporting processes, using that information to make decisions about the Company's activities and to determine the form and timing of funding for those activities.

Audalia has been able to demonstrate a record of securing funds when required (refer to ASX announcements dated 6 March 2020 - Completion of Placement and Appendix 2A, 11 July 2019 – Update on funding and capital raising, 20 June 2018 – Shortfall on entitlement issue and 16 March 2018 – Update on Funding) and is confident that it will be able to continue to do so.

Answer:

The Company expects to continue its operations and to meet its business objectives as it is confident that it will be able to continue to raise funds as and when required. This expectation is based on past experience (as noted above) and because Audalia continues to have the support of its major shareholders and lenders to continue to advance the approvals for the Medcalf Project (refer to ASX announcements dated 29 July 2019 – Update on Loan Facilities and 16 March 2018 – Update on Funding).
