Answer: The Company expects to have reduced operating and exploration expenditure in the following quarters due to the finalisation of its drilling activities on its permits in West Mali.

Answer: The Company will continue to monitor its available cash and is reducing its operating expenditure going forward. If required, the Company may seek to raise funds for its ongoing activities, noting that it has its full placement capacity available under LR7.1 plus the additional temporary emergency capacity (additional 10% subject to conditions), if required.
