

# **Body Composition Technologies signs definitive** agreements with Active8me

MyFiziq Limited (ASX: BCT) ("Body Composition Technologies" or the "Company") would like to inform shareholders that, in addition to the signing of definitive agreements with MyFiziq Limited (as announced to ASX on 28 April 2020), Body Composition Technologies Pte Ltd ("BCT"), MyFiziq's 50% owned joint venture partner, has now signed definitive agreements with Active8me Pte Ltd (Active8me), which will see the integration of the BCT platform into the Active8me health and wellness platform.

The agreements are identical in nature with the exception of the differing business verticals BCT operates in being, insurance, medical and government research.

Description	The BCT Commercial Contract is the main commercial agreement between the parties pursuant to which BCT agrees, inter alia, to grant a licence to Active8me to use BCT's licensed software development kits and related intellectual property to integrate them into the Active8me platform/technology. In return, Active8mehas agreed to pay certain user fees, data storage fees, support fees and incidental support fees to BCT.  The BCT Software Development Kit, End User License Agreement, BCT Support Agreement and BCT Data Processing Agreement are support
F' '17	agreements related to the BCT Commercial Contract.
Financial Impact	BCT does not expect any immediate material financial return as a result of entering into the contracts. However, as the Active8me platform (integrated with the BCT SDKs) is rolled out in Asia, BCT expects to start generating licence and other fees from the commercial arrangement (which cannot be forecast at this time).
Initial Term	1 year, which term shall be renewed for consecutive further terms of 2 years each (unless terminated at least 30 days prior to expiry of the term).
Termination	The contracts may be terminated in the event that the counterparty is in material breach, suffers an insolvency event or sells its business or a majority of the shares in the counterparty (i.e. change in control).  There is no termination for convenience clause.
Governing Law	Singapore
