MGC Pharmaceuticals Ltd (ASX: MXC, ‘MGC Pharma’ or ‘the Company’), a European based ‘Seed to Medicine’ bio-pharma company specialising in the development and production of phytocannabinoid-derived medicines, is pleased to announce that the placement to raise A\$3.5 million (**‘Placement’**) at A\$0.027 per share, has been completed today following the issue of 129.63m fully paid ordinary shares (**‘New Shares’**) to Placement participants.

As announced 28 April 2020, MGC Pharma secured firm commitments from new and existing institutional and sophisticated investors to raise A\$3.5 million through the issue of 129.63m New Shares at an issue price of A\$0.027 per New Share. New Shares issued under the Placement include one free attaching listed option (**‘Option’**) for every two New Shares issued, exercisable at A\$0.045 on or before 31 August 2021. The Options are being issued under the Company’s prospectus dated 4 May 2020 (**‘Prospectus’**). The offers for the SPP Options and the Placement Options will remain open, in accordance with the timetable set out in the Prospectus.
