Melbourne 13 May 2020: Bubs Australia Limited (ASX: **BUB**) advises that Mrs Kristy Carr has informed the Company that her Family Trust has sold 3,141,000 shares on 6 May 2020 and now holds 13,620,600 fully paid ordinary shares, plus 4,770,810 unlisted performance options.

Mrs Carr has advised Bubs Australia that the sale of the shares was to meet personal tax obligations due mid-May 2020.

After C2 Capital Partners, Mrs Carr remains the single largest shareholder in Bubs Australia, holding 2.43 percent of the issued share capital. Mrs. Carr has made no sales of shares in Bubs since May 2019 to acquire a new family home. The sale was made in accordance with the Company's securities trading policy, including Board pre-trade approvals.

Mrs Carr advised the company that she believes strongly in the future prospects for Bubs and as a founding shareholder is fully aligned with the business growth agenda. She has no immediate plans to sell more shares.
