The Issue related to a Finance Facility of \$5 million. The Company can draw down in tranches of \$1 million for the first tranche and second tranches between \$400,000 and \$1 million. The facility has a term of 12 months.  
Under the LSW Facility, the Company can at its option raise funds by placement tranches of A\$1 million each to LSW, at a subscription price equals to the average of the 5 daily Volume Weighted Average Price (VWAP) of the Share immediately prior to subscription.
