## **Netlinkz Limited subsidiary, iLinkAll and M-Soft partner with AI Data Innovations to provide a global Secure Telecommuting product**

**NetLinkz Limited (ASX: NET)** today announces that its majority-owned entity, the Beijing iLinkAll Science and Technology Co. (**iLinkAll**), has been engaged by AI Data Innovations to work with MSoft (Shanghai M-Soft Information Technology Co. Ltd.) to provide a secure global telecommuting solution, a USB edge device, to replace its traditional VPN for consultants and employees working from home.

Seattle based AI Data Innovations is a world leader in data management for Machine Learning operating in 200 markets with a global workforce of 300,000+ people and coverage of over 100 languages, and has selected iLinkAll to work with its multinational customer base.

This solution will leverage iLinkAll's VSN secure mobile product to bridge the remote working user and the corporate system that monitors and transmits sensitive data (audio and video) securely, meeting both high security and privacy requirements. The joint solutions are expected to be applicable to many different Industry Verticals including Autonomous Vehicles, Smart City Transportation and Traffic Data Process Systems.

Revenue will be generated by iLinkAll from the design phase as well as monthly subscription fees from each customer it secures. It is expected the design phase will take up to 8 weeks, with target completion on or around July 31 2020, followed by the subscription and services fees to be negotiated with customers thereafter. The Company expects this product collaboration with AI Data Innovations to provide a strong pipeline to derive revenues from AI Data Innovations' sizable customer base, however the Company will not be in a position to update its revenue guidance until these subscriptions and service contracts have been negotiated and secured. The Company will continue to keep investors updated on any material developments in this regard.

James Tsiolis, Executive Chairman and CEO of NetLinkz said: "This latest product collaboration demonstrates the capability of the VSN product and its flexibility to be bundled into an aggregated commercial solution. Our collaboration is focused on delivering a global product through an established sales channel. We expect to earn subscription and service fees based on customer take up rates."

iLinkAll President Zen Wang said: "I am pleased that our innovative services and solutions continue to be identified to secure networks by global businesses and operations. Enabling secure and private remote working capabilities has never been more important and we are pleased to be collaborating with global leaders."
