Highlights

- Oseil-29 development well producing ~400 bopd with ~170 bwpd
- Operator plans to slowly increase rate to 600-700 bbls of fluid a day
- PSC production exceeds 2000 bopd for first time since March 2018

Lion Energy Limited ("Lion") is pleased to report that the Oseil-29 development well has been completed having been drilled to a total depth of 2321m MD. The well was located to develop undrained reserves in the northeast¹ portion of the Oseil 2 producing area which has produced approximately 9 mmbbl to date out of Oseil and surrounding fields area total production of 18.28 mmbbl.

Oseil-29 is currently (as at 28 May 2020) producing oil at 399 bpd with 168 bpd of water from the fractured Manusela Carbonate reservoir. The Operator of the Seram (Non-Bula) PSC, CITIC Seram Energy Ltd, is monitoring the water rate and slowly increasing flow from the well to a target 600 to 700 barrels of fluid per day. The water is interpreted to likely be coming from the lower section of the well and options exist to isolate potential water bearing fractures.

Lion has a 2.5% interest in the Seram (Non-Bula) PSC and a 60% interest and operatorship of the surrounding East Seram PSC.
