ISSUE OF SECURITIES – APPENDIX 2A and S708A Notice

European Lithium Limited (ASX:EUR, FRA:PF8, VSE:ELI, NEX:EUR) (the **Company**) advises that 12,609,401 fully paid shares (**Shares**) and 12,609,401 unlisted options with an exercise price of \$0.05 (5 cents) and expiry date of 31 July 2022 (**Options**) have been issued on 29 May 2020.

In respect to the securities issued, a total of 10,609,401 Shares and 10,609,401 Options were issued pursuant to the conversion of debt (refer announcement dated 27 May 2020). The Company expects that the remainder of the Shares and Options to be issued pursuant to the conversion of debt will be issued on or prior to 5 June 2020.

The balance of 2,000,000 Shares and 2,000,000 Options were issued to Empire Capital Partners in respect to the Talaxis engagement (refer announcement dated 27 May 2020).
