Notice under Section 708A(5)(e) of the Corporations Act 2001 (Cth)

RTG Mining Inc. (TSX: RTG, ASX: RTG) ("**RTG**" or the "**Company**") advises that it has issued 60,128,550 new CHESS Depository Interests ("**CDIs**") (representing 60,128,550 fully paid ordinary shares in the share capital of the Company) at a deemed issue price of A\$0.057 per CDI ("**Placement CDIs**") pursuant to the settlement of tranche one of the placement to institutional and sophisticated investors announced on 22 May 2020. The Placement CDIs rank equally with other CDIs on issue.

RTG gives notice under section 708A(5)(e) of the *Corporations Act 2001* (Cth) ("**Corporations Act**") as modified by ASIC Class Order 14/827 that:

- the Placement CDIs were issued without disclosure to investors under Part 6D.2 of the Corporations Act;
