#### **ISSUE OF SHARES – APPENDIX 2A and S708A Notice**

European Lithium Limited (ASX:**EUR**, FRA:PF8, VSE:ELI, NEX:EUR) (the **Company**) advises that 9,166,666 shares have been issued on 5 June 2020.

In respect to the shares issued, a total of 5,454,544 were issued pursuant to the conversion of 300 convertible notes (refer ASX announcement 5 March 2020).

The balance of 3,712,122 shares have been issued to convert \$118,182 of debt into equity. The issue is made using the Company's existing capacity under Listing Rule 7.1 and without shareholder approval.

A completed Appendix 2A is lodged with ASX.
