**Notice Given Under Section 708A(5)(e) of the Corporations Act**

Predictive Discovery Limited (**Company**) gives notice to the ASX for the purpose of Section 708A(5)(e) of the *Corporations Act 2001* (the '**Act**'), that on 15 June 2020 it issued and allotted a total of 138,000,000 fully paid ordinary shares at \$0.05 per share (**Shares**) to raise \$6.9 million (before costs) without disclosure under Part 6D.2 of the Act. Shareholder approval to issue the shares was obtained at an EGM on 10 June 2020.
