ZELIRA THERAPEUTICS LIMITED – UPCOMING GENERAL MEETING OF SHAREHOLDERS

Zelira Therapeutics Limited (ASX:ZLD) (Zelira or the Company) will hold a General Meeting of its shareholders (Shareholders) at 9.00am (WST) on Tuesday, 21 July 2020 (the Meeting). The Company advises shareholders that the Meeting will be held in compliance with the Australian government's restrictions on public gatherings.

In accordance with temporary modifications to the Corporations Act under the Corporations (Coronavirus Economic Response) Determination (No. 1) 2020, the Company is not sending hard copies of the Notice of Meeting to Shareholders. Due to the COVID-19 situation, it may not be possible for Shareholders to physically attend the Meeting. As a result, the Company strongly encourages all Shareholders to vote by directed proxy in lieu of attending the meeting in person. As at the date of this Notice, the Company intends to hold a physical in-person Meeting, so long as the number of attendees remains within the limits permitted under the latest public gathering restriction guidelines. In the event that the number of attendees exceeds that permitted, the Meeting Chairperson will adjourn the Meeting in the interests of the safety of all involved, for it to be resumed at a later date.

If it becomes necessary to make changes to the current arrangements for the Meeting, Zelira Therapeutics will advise Shareholders through its website and by making an ASX announcement.
