NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

On 2 July 2020 Amani Gold Limited (ASX: ANL) (**Amani** or the **Company**) issued 1,003,700,000 shares at \$0.001 per share (**Placement Shares**) as the first of a two-tranche Placement using the Company's issue capacity provided under Listing Rule 7.1 (**Tranche 1 Placement**), with an Appendix 2A in respect of the Placement released on the same day.
