EXCEPTIONAL INTERCEPT OF 37m AT 6.21g/t OUTSIDE CURRENT ORE RESERVE AT APHRODITE

RESULT SHOWS THE SIGNIFICANT UNTESTED POTENTIAL OF THE OMEGA LODE AND POTENTIAL RESERVE GROWTH

Key Points:

- Broad, high-grade gold intercepts returned from untested locations within the Omega Lode, and have the potential to significantly add to the reserves of this lode. Best results include:
 - 37m @ 6.21g/t Au from 90m including 13m @ 10.94g/t Au from 90m in 20APRC0006
 - 7m @ 8.95g/t Au including 4m @ 15.07g/t Au from 132m in 20APRC0001
 - 4m @ 5.24g/t Au from 158m in 20APRC0003
- Results support nearby results from the Omega Lode reported on 8 April 2020:
 - 3.7m @ 9.51g/t Au from 208.6m in 19APDM006
- Demonstrates potential for extensions to existing lodes and additional discoveries within the multilode system.
- RC drilling continues at Zoroastrian, with Excelsior and Mayday North to follow.
- Drilling will recommence at Mayday North and North Kanowna Star upon the interpretation of the recent geophysical survey.
- DFS geotechnical work on track and ahead of schedule, DFS metallurgical testwork progressing well.

Bardoc Gold Limited (ASX: **BDC**, **Bardoc** or **the Company**) is pleased to report outstanding new results from recent reverse circulation drilling at the Aphrodite Deposit, part of the Company's 100%-owned **3.02Moz Bardoc Gold Project** located 40km north of Kalgoorlie in WA.

Recent drilling within the Omega Lode has intersected further broad zones of gold mineralisation outside of the current Ore Reserves, highlighting the strong potential to identify areas of broad, high-grade gold mineralisation to add to current Ore Reserves within the cornerstone 1.68Moz Aphrodite multi-lode system.

The latest drilling success at Aphrodite comes as exploration continues to gather momentum on several fronts across the 3.02Moz Bardoc Gold Project.



APHRODITE OMEGA LODE DRILLING RESULTS

The cornerstone Aphrodite Deposit hosts current Ore Reserves totalling 500,000oz from both open pit and underground sources. The latest outstanding drilling results confirm the potential for untested areas of the Aphrodite Deposit to deliver additional mineralisation that will likely have a positive impact on the long-term future of the mine.

The Aphrodite Deposit, with a current Mineral Resource of 1.68Moz, consists of multiple lodes – Alpha, Phi, Epsilon, Sigma and Omega. The results reported in this announcement are from the Omega Lode. Omega is a generally thought to be narrow, high-grade lode located some 20-40m west of the Phi Lode. The Omega Lode broadly follows a contact between a basalt and sediment with fine grained arsenopyrite carrying the gold mineralisation. These recent results are much wider than the average intercepts.

There are large untested areas at Aphrodite and these results confirm there are still discoveries to be made that will positively impact the Company's Definitive Feasibility Study (DFS) plans. The new results include:

- 37m @ 6.21g/t Au including 13m @ 10.94g/t Au from 90m in 20APRC0006
- 7m @ 8.95g/t Au including 4m @ 15.07g/t Au from 132m in 20APRC0001
- 4m @ 5.24g/t Au from 158m in 20APRC0003

Follow-up drilling is being planned to fully test the lateral extents of this mineralisation and will be undertaken in coming months.

EXPLORATION UDPATE

Air-core drilling in the vicinity of the proposed mill and future tailings dam sites has commenced as part of a sterilisation and data gathering program. Areas west of the Aphrodite Deposit, Mayday North and North Kanowna Star will also be tested, where a multi-pronged 40,000m drill program has been planned, targeting potential new discoveries.

MANAGEMENT COMMENTS

Bardoc Gold's Chief Executive Officer, Mr Robert Ryan, said the outstanding intercept of 37m at 6.21g/t including an exceptional high-grade zone of 13m at 10.94g/t was one of the best drilling results generated from the Aphrodite deposit to date.

"These breakthrough results clearly demonstrate the potential for significant Reserve growth at our cornerstone Aphrodite Deposit. Once again, a systematic and scientific approach to exploration has paid dividends with in-fill resource drilling delivering grades and widths well above expectation, further increasing our confidence in the geological models and identifying significant new areas of growth.

"These latest results will go into our resource update at the end of September, with the overall aim of converting our 1Moz production target into JORC compliant mining reserves.

"With the resource in-fill programs now underway at Excelsior and Zoroastrian, the focus will soon turn to exploration, where we plan to embark on a 40,000m drill program targeting the highly prospective areas at Mayday North, North Kanowna Star, and the Black Flag Fault and Bardoc Tectonic Zone interaction.

"The recently completed capital raising has brought on board a number of Tier-1 Australian and Global Institutions who will support the company through the completion of the DFS and into production. We can now look forward with confidence and to begin early pre-production works in order to achieve our vision of becoming a mid-tier gold producer as expeditiously as possible."



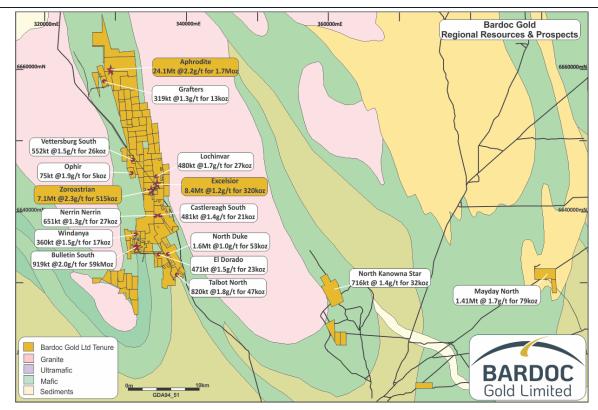


Figure 1. Bardoc Gold Project, tenement location plan.

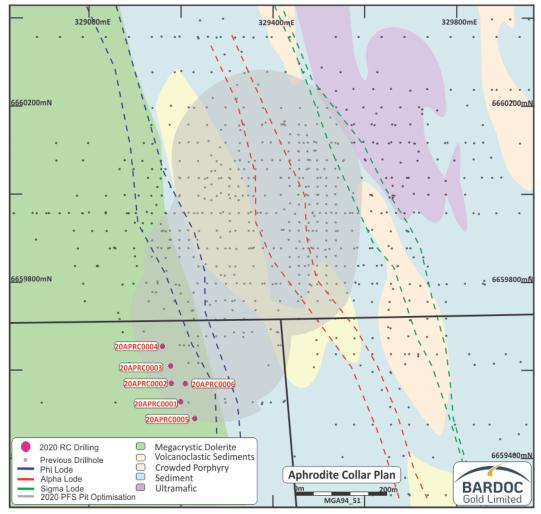


Figure 2. Aphrodite drill-hole location plan



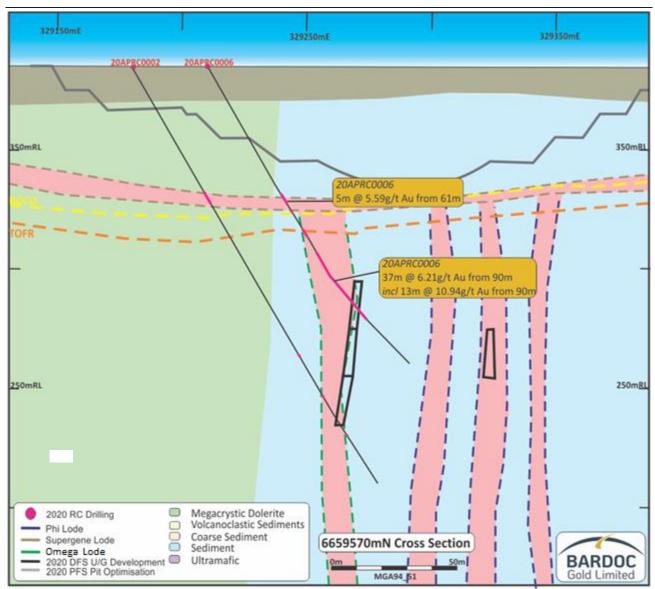


Figure 3. Aphrodite Phi and Omega Lode Cross section 6659570mN, +/- 20m, looking north

NEXT STEPS

- Ongoing work to finalise the processing plant location, engineering and borefield capacity.
- RC drilling at Excelsior and Mayday North to extend the mineralisation.
- Exploration Air-core drilling north of the planned mill site, as well as upcoming drilling programs at Aphrodite, Mayday North and Kanowna Star.
- Permitting for the Feasibility Study with stakeholders including several State Government Departments.

BARDOC GOLD PROJECT – BACKGROUND

The Bardoc Gold Project was formed in October 2018 following completion of the merger between Excelsior Gold and Spitfire Materials, bringing together significant resources and excellent potential for growth. The Bardoc Gold Project runs contiguously north for 40km in the Eastern Goldfields. There are four main deposits and a multitude of smaller projects within the 250km² land-holding, providing a large Resource base and excellent exploration potential within the prolific Norseman-Wiluna greenstone belt and junction of the Bardoc Tectonic Zone (BTZ) and the Black Flag Fault (BFF).

These two deep-seated crustal structures host many multi-million-ounce deposits, including the world-renowned Golden Mile in Kalgoorlie.

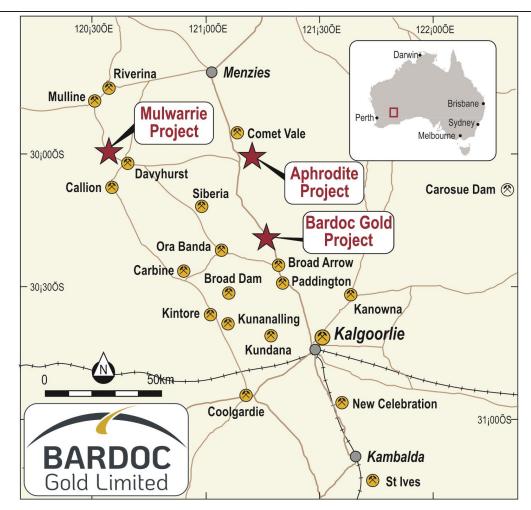


Figure 4: Project Location Plan

BDC RC recovered chip samples were collected and passed through a cone splitter. Elmited numbers of field duplicates and screen fire assays have been undertaken to support sample appresentivity. BDC DC core has been sampled by submission of cut quarter core. All BDC RC drilling was sampled on one metre down hole intervals. The recovered samples were passed through a cone splitter and a nominal 2.5kg 3.5kg sample was taken to a kalgoorile contract laboratory. Samples stage process to 85% passing 75 µm. The sample is then prepared by standard fire assay techniques with a 40g charge.

of the drilling is logged, and where no sample is returned due to voids (or potentially lost sample) it is logged and recorded as such. Drill core is logged over its entire length and any core loss or voids intersected are recorded.

Sub-sampling techniques and sample preparation

- If core, whether cut or sawn and whether quarter, half or all core taken.
- If non-core, whether riffled, tube sampled, rotary split, etc and whether sampled wet or dry.
- For all sample types, the nature, quality and appropriateness of the sample preparation technique.
- Quality control procedures adopted for all subsampling stages to maximise representivity of samples.
- Measures taken to ensure that the sampling is representative of the in situ material collected, including for instance results for field duplicate/second-half sampling.
- Whether sample sizes are appropriate to the grain size of the material being sampled.

- BDC Exploration results reported in this announcement are for quarter cut drill core taken from the right hand side of the core looking down hole. Core is cut by BDC staff onsite at the core cutting facility.
- All BDC RC samples are put through a cone splitter and the sample is collected
 in a unique pre-numbered calico sample bag. The moisture content of each
 sample is recorded in the database.
- The BDC RC samples are sorted, oven dried, the entire sample is pulverized in
 a one stage process to 85% passing 75 µm. The bulk pulverized sample is then
 bagged and approximately 200g extracted by spatula to a numbered paper
 bag that is used for the 50g fire assay charge.
- The BDC DC samples are oven dried, jaw crushed to nominal <10mm, 3.5kg is obtained by riffle splitting and the remainder of the coarse reject is bagged while the 3.5kg is pulverized in a one stage process to 85% passing 75 μm. The bulk pulverized sample is then bagged and approximately 200g extracted by spatula to a numbered paper bag that is used for a 40g or 50g fire assay charge.</p>
- against the submission documents. BDC inserts blanks and standards with blanks submitted in sample number sequence at 1 in 50 and standards submitted in sample number sequence at 1 in 50 and standards submitted in sample number sequence at 1 in 20. The laboratory uses their own internal standards of 2 duplicates, 2 replicates, 2 standards, and 1 blank per 40 or 50g fire assay batch. The laboratory also uses barren flushes on the pulveriser.
- In the field every 10th metre from the bulk sample port on the cone splitter is bagged and placed in order on the ground with other samples. This sample is then used for collection of field duplicates via riffle splitting. RC field duplicate samples are collected after results are received from the original sample assay. Generally, field duplicates are only collected where the original assay result is equal to or greater than 0.1g/t Au. The field duplicates are submitted to the laboratory for the standard assay process. The laboratory is blind to the original sample number.
- For DC, historically no core duplicates (i.e. half core) have been collected or submitted. BDC inserts blank samples and standards at the rate of about 1 in 20. The results and core used for this announcement will undergo metallurgical testwork, this will involve performing check assays on the samples which will act as a field duplicate.
- The sample sizes are considered to be appropriate for the type, style, thickness and consistency of mineralization located at this project. The sample size is also appropriate for the sampling methodology employed and the gold grade ranges returned.

Quality of assay data and laboratory tests

- The nature, quality and appropriateness of the assaying and laboratory procedures used and whether the technique is considered partial or total.
- For geophysical tools, spectrometers, handheld XRF instruments, etc, the parameters used in determining the analysis including instrument make and model, reading times, calibrations factors applied and their derivation, etc.
- Nature of quality control procedures adopted (e.g. standards, blanks, duplicates, external laboratory checks) and whether acceptable levels of accuracy (i.e. lack of bias) and precision have been established.
- BDC has routinely used local Kalgoorlie Certified Laboratories for all sample preparation and analysis. The most commonly used laboratories have been SGS Australia, Bureau Veritas Australia and Intertek. No complete details (i.e. most details captured, but not all details for all holes) of the sample preparation, analysis or security are available for either the historic AC, DD or RC drilling results in the database.
- The assay method is designed to measure total gold in the sample. The
 laboratory procedures are appropriate for the testing of gold at this project
 given its mineralization style. The technique involves using a 40g or 50g
 sample charge with a lead flux which is decomposed in a furnace with the prill
 being totally digested by 2 acids (HCl and HNO3) before measurement of the
 gold content by an AA machine.
- The QC procedures are industry best practice. The laboratories are accredited and use their own certified reference materials.
- BDC submits blanks at the rate of 1 in 50 samples and certified reference
 material standards at the rate of 1 in 20 samples in the normal run of sample
 submission numbers. As part of normal procedures BDC examines all
 standards and blanks to ensure that they are within tolerances. Additionally,
 sample size, grind size and field duplicates are examined to ensure no bias to
 gold grade exists.

Verification of sampling and assaying

- The verification of significant intersections by either independent or alternative company personnel.
- The use of twinned holes.
- Documentation of primary data, data entry procedures, data verification, data storage (physical and electronic) protocols.
- Discuss any adjustment to assay data.
- BDC's Exploration Manager and site geologist have inspected RC chips and drill core in the field to verify the correlation of mineralized zones between assay results and lithology/alteration/mineralization
- A number of RC holes have also been drilled that confirmed results obtained from historical drillholes. No holes have been directly twinned, there are however holes within 12m of each other.
- Primary data is sent digitally every 2-3 days from the field to BDC's Database Administrator (DBA). The DBA imports the data into the commercially

Incomplete down hole surveying information is available for the historic RC or DD drilling. No detailed down hole surveying information is available for the historic RC or DD drilling. BDC routinely contracted down hole surveys during the programmes of exploration drilling for each RC and DC drill hole completed using either digital electronic multi-shot tool or north seeking gyro, both of which are maintained by Contractors to manufacturer specifications. The current drill program was downhole surveyed by the drill contractor using a north seeking gyro. All drill holes and resource estimation use the MGA94, Zone 51 grid system. The drill spacing, spatial distribution and quality of assay results is sufficient to support the JORC classification of material reported previously and is appropriate for the nature and style of mineralisation being reported.
