ISSUE OF PLACEMENT SHARES

Gage Roads Brewing Co Ltd ("Gage Roads" or "The Company") (ASX: GRB) advises that 100,000,000 ordinary shares have been issued today to institutional investors at \$0.052 per raising gross proceeds of \$5.2m pursuant to the placement first announced by the Company on 6 July 2020 (Institutional Placement).

The Placement to the institutional investors was made without shareholder approval in reliance on the Company's 15% annual placement capacity under ASX Listing Rule 7.1.
