### Tranche 2 Placement Completed & Cleansing Notice

De Grey Mining Limited (ASX: DEG, De Grey or Company) is pleased to confirm the allotment of 19,232,142 ordinary fully paid shares to DGO Gold Limited (18,232,142) and Mr. Peter Hood (1,000,000) following shareholder approval on 10 July 2020 and representing the 2<sup>nd</sup> Tranche of the placement initially announced on 28 April 2020.

In addition, the Company has allotted 1,000,000 ordinary fully paid shares on exercise of 1,000,000 unlisted options exercisable at 10 cents (*which options were issued with disclosure*) and 150,000 unlisted options exercisable at 30 cents.
