G Medical to expand remote patient monitoring services into Australia and New Zealand

- **Expanded agreement with Australian partner HSC Technology Group (ASX: HSC) will allow hospitals and other healthcare providers access to 24-hour remote patient monitoring services**
- **Provides another sales channel for G Medical's Prizma and Patch devices and further scales up the Company's Independent Diagnostic Facilities Testing (IDTF) type infrastructure**
- **Large market opportunity for GMV with new and in association with HSC's aged care and healthcare partners – shared revenue model based on tiered subscription model of ~A\$19-\$35 per month**

Mobile and Telehealth company **G Medical Innovations (ASX: GMV)** ("**G Medical**" or the "**Company**") advises that it has expanded its agreement with connected health and smart home solutions provider HSC Technology Group (ASX: HSC) ("HSC Technology Group") to offer G Medical's Independent Diagnostic Facilities Testing (IDTF) type infrastructure and remote patient monitoring solutions in Australia and New Zealand.

The development follows an initial non-exclusive agreement with HSC Technology Group secured in April, where G Medical integrated its Prizma device into HSC's uVue telehealth platform to monitor the vital signs of elderly patients in a nursing home setting. This broadened agreement allows G Medical to now introduce its 24-hour remote patient monitoring service through an established and respected partner that has leading assistive technology platforms.

The expanded offering deliver to patients a more comprehensive service which can be utilised by hospitals, health insurance companies and independent practice organisations, and other operators for transitional care programs, allowing patients to return home earlier by using 24-hour remote patient monitoring. The infrastructure allows for similar patient services as currently provided by G Medical's wholly owned IDTF operations in the US, while additionally provisioning for independent telehealth and remote patient monitoring infrastructure access to the aforementioned healthcare providers.

Patients enrolled under the service will be charged a subscription fee ranging from ~\$A19-\$35 per month, which will be shared between G Medical, HSC Technology Group and third-party providers. Further, the establishment will help G Medical cement its footprint in Australia and New Zealand and unlock another sales channel for its TGA-approved Prizma and Patch devices.

HSC Technology Group has an established network of healthcare solution resellers and healthcare providers, with significant patients numbers across Australia and New Zealand and G Medical is confident of implementation in the near term. Discussions with potential partners are well progressed and G Medical looks forward to providing updates on binding agreements and first patient enrolments when appropriate.

G Medical Director Dr Brendan de Kauwe said: *"The launch of a 24-hour remote patient monitoring service in Australia with a trusted and respected partner like HSC presents us with yet another avenue to grow our patient*

services infrastructure and recurring revenues, as well as another network to deploy our medical devices and secure sales for our Prizma and our Patch.

“HSC Technology Group will unlock an established network of healthcare providers and resellers, as well as a leading technology platform that G Medical can leverage quickly to drive uptake in Australia and New Zealand. HSC have been impressed with our IDTF platforms, our robust systems and processes, and they recognise its potential to be integrated into their offering.

Managing Director & CEO Dr Yacov Geva added: *“Australia and New Zealand are important markets for G Medical and we believe we can establish a solid business here with the right partners. HSC is such a partner. We are rapidly expanding our IDTF operations in the US through the hospital system and building a deep sales pipeline for our Patch and Prizma in a number of markets. More news on sales progress is pending.”*
