

MyFiziq receives \$450,000 in payments from Body Composition Technologies Pte Ltd

Highlights

- MyFiziq receives \$250,000 in integration and development revenue.
- BCT pays \$200,000 licence fee instalment.
- MyFiziq completes subscription for convertible notes in BCT.

MyFiziq Limited (ASX: MYQ) (MyFiziq) is pleased to update shareholders with the following information regarding its joint venture with Body Composition Technologies Pte Ltd (**BCT**).

As disclosed to the ASX on 20th July 2020, MyFiziq outlined that it anticipated receiving payments from joint venture partner, BCT, to the total of \$450,000. The breakdown of the payments is as follows, \$250,000 in payments due to MyFiziq for work carried out on partner builds and integrations. The balance of the \$450,000 received was a license fee instalment of \$200,000 which forms a part payment toward the balance of the \$500,000 license fee owing to MyFiziq under the now updated joint venture agreement with BCT.

MyFiziq has now received these payments from BCT in full.

Furthermore, MyFiziq has concluded its uptake of the \$670,833,33 of convertible notes in BCT as previously disclosed.

Vlado Bosanac, Group Chief Executive Officer of MyFiziq, said:

"As anticipated, we have now received all outstanding payments from BCT pertaining to the development and partner integrations we have carried out. In addition to this, we have received the second of 3 instalments agreed with Gold Quay Capital and BCT towards the \$2,000,000 license fee due under the joint venture agreement. Under this agreement, the balance of \$300,000 will be due in November this year, when Gold Quay Capital anticipates concluding the balance of the convertible note funding into BCT."
