

COMPLETION OF TRANCHE 1 PLACEMENT

On 29 July 2020, Talon Petroleum Ltd (ASX:TPD) (**Company**) completed the issue of 444,197,380 Tranche 1 Placement Shares as set out in the Company's Appendix 3B dated 23 July 2020.

As announced 23 July 2020, Talon secured firm commitments from new and existing institutional and sophisticated investors to raise A\$5 million through the issue of 2.5 billion New Shares at an issue price of A\$0.002 per New Share. New Shares issued under the Placement include one free attaching unlisted option ('**Option**') for every two New Shares issued, exercisable at A\$0.004 on or before 28 February 2022. The Options and Tranche 2 Placement Shares are subject to shareholder approval at the Company's General Meeting to be held late August.

Pursuant to section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**), the Company gives notice that:

- (a) the Company issued the Shares without disclosure under Part 6D.2 of the Corporations Act; and
- (b) as at the date of this notice, the Company has complied with the provisions of Chapter 2M of the Corporations Act as they apply to the Company;
- (c) as at the date of this notice, the Company has complied with section 674 of the Corporations Act as it applies to the Company; and
- (d) as at the date of this notice, there is no information:
 - (i) that has been excluded from a continuous disclosure notice in accordance with the ASX Listing Rules; and
 - (ii) that investors and their professional advisers would reasonably require for the purpose of making an informed assessment of:
 - A. the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - B. the rights and liabilities attaching to the Shares.
