Major shareholder and director Jihad Malaeb provided a loan in the amount of \$300,000 in the March 2020 quarter. The loan is to be secured through a convertible note and security over Company assets to the value of the loan. Interest payable on the loan is 10% per annum. During the March 2020 quarter, \$283,000 of the loan was drawn down.

Major shareholder Sufian Ahmad provided a loan in the amount of \$100,000 on the same terms. During the March 2020 quarter the loan was fully drawn down.

The Company will seek shareholder approval as required under the Corporations Act and the Listing Rules.

Answer: Yes

Answer: Yes, The Company proposes to raise additional capital as required by the ASX to reinstate the Company's securities to quotation. The Company successfully raised \$50K in July. The Company is currently suspended from trading. Subsequent to 30 June 2020, the Company sought advice from the ASX in relation to the Company's securities being reinstated to trading. ASX advised that the Company can commence trading once the statutory accounts for year end 2019 are lodged and that the Company has a minimum \$1.5M working capital position. The Company is currently working towards those objectives.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes. The Company has reasonable expectations that sufficient working capital will be available for continued business operations through short term fundraising and upon achieving a minimum \$1.5M working capital position.
