

QUARTERLY REPORT TO 30 JUNE 2020

HIGHLIGHTS

- **Metallurgical Pilot Scale Testwork completed by GZRINM**
- **Environmental Review Document (ERD) being finalised for submission**

Audalia Resources Limited (ASX: **ACP**) is pleased to present its report for the June 2020 quarter.

MEDCALF PROJECT

The Medcalf Project is a vanadium-titanium-iron project located some 470 kilometres south east of Perth near Lake Johnston, Western Australia. The Medcalf Project comprises three granted Exploration Licences E63/1133, E63/1134 and E63/1855 as well as mining lease M63/656 and miscellaneous licence L63/75. Together, these licences cover a total area of 38 km².

The Medcalf Project lies in the southern end of the Archaean Lake Johnston greenstone belt. This greenstone belt is a narrow, north-northwest trending belt approximately 110 km in length. It is located near the south margin of the Yilgarn Craton, midway between the southern ends of the Norseman-Wiluna and the Forrestania-Southern Cross greenstone belts.

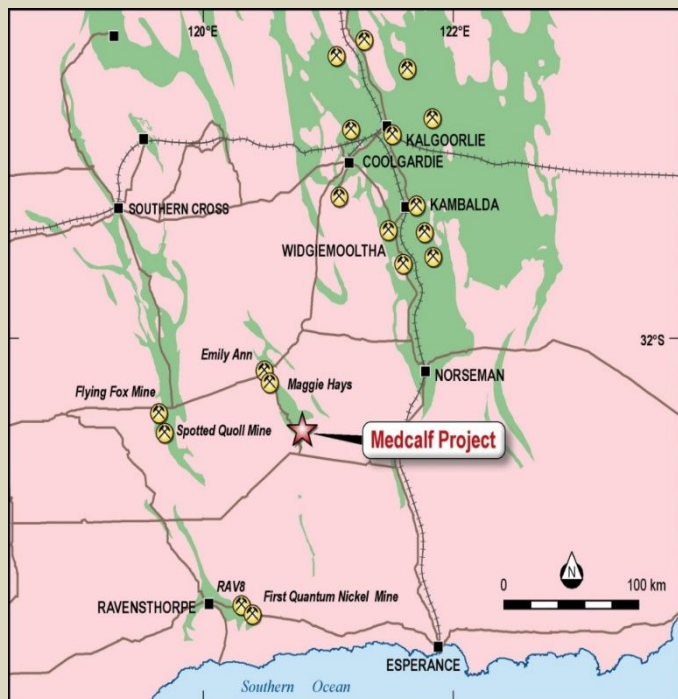


Figure 1: Medcalf Project - Location Map

Environmental Approval

During the quarter, Audalia and its environmental consultants finalised the Environmental Review Document (ERD) for the Medcalf Project. The ERD was submitted to the Environmental Protection Authority (EPA) of Western Australia on 14 July 2020.

The submission represents a significant milestone in the approvals process for the Medcalf Project, and the ERD document confirms that the Project can meet the scope of work outlined in the EPA approved Environmental Scoping Document (ESD).

The EPA will review the ERD document and provide feedback to the Company prior to the document being released for public review.

Metallurgical Test Work

Guangzhou Research Institute of Non-Ferrous Metals (GZRINM) undertook an interim metallurgical test work in 2017 and developed a viable metallurgical flowsheet to process the ore from the Medcalf Project (refer ASX announcement dated 26 October 2017). The flowsheet includes two-stage magnetic separation, magnetising roasting, magnetic separation and gravity separation. The flowsheet provides a feasible technical route for the comprehensive recovery of iron, vanadium and titanium from the Medcalf Project.

GZRINM has successfully completed the beneficiation and pyrometallurgical pilot scale test work in the previous quarters. In the June 2020 quarter, GZRINM completed the remaining separation circuit pilot scale test work. The separation circuit is to separate the pyrometallurgical process product and includes magnetic separation and gravity separation. Two final concentrate products, namely vanadium contained iron concentrate and titanium dioxide concentrate, will be produced from the separation circuit.

The pilot scale test work of the entire process flowsheet has now been successfully completed by GZRINM. The final pilot scale test work report is currently being prepared by GZRINM and the results are expected to be reported in the September 2020 quarter.

CORPORATE MATTERS

The Company had cash and cash equivalents as at 30 June 2020 of \$53,000 (Q3: \$204,000) following payments for capitalised exploration and evaluation expenditure of \$264,000 (Q3: \$423,000) and payments to related parties and their associates of \$26,000 (Q3: \$35,000) during the June 2020 quarter.

In June 2020, the Company negotiated access to a loan facility of up to \$500,000 from a director, Siew Swan Ong, to meet its working capital requirements (**Related Party Loan Facility**). The Related Party Loan Facility is unsecured, provided on interest free and fee-free terms and has a repayment date of 30 June 2022, which may be extended on the same terms by mutual agreement. Full details of the Related Party Loan Facility are set out in the ASX release dated 16 June 2020.

The Company acknowledges its cash position at the end of the quarter and its estimated cash available for future operating activities. The Directors continue to assess funding alternatives to ensure the Company can continue exploration and evaluation activities at the Medcalf Project.

Answer:

Audalia is in the exploration and evaluation phase of its flagship Medcalf Project and as a result, expects to have negative operating cash flows for the time being.

Answer:

Audalia manages its cash flow through ongoing budgeting, forecasting and financial reporting processes, using that information to make decisions about the Company's activities and to determine the form and timing of funding for those activities.

Audalia has been able to demonstrate a record of securing funds when required (refer to ASX announcements dated 16 June 2020 – Funding Update, 6 March 2020 - Completion of Placement of \$360,000, 11 July 2019 – Update on funding and capital raising, 20 June 2018 – Shortfall on entitlement issue and 16 March 2018 – Update on Funding) and is confident that it will be able to continue to do so.

Answer:

The Company expects to continue its operations and to meet its business objectives as it is confident that it will be able to continue to raise funds as and when required. This expectation is based on past experience (as noted above) and because Audalia continues to have the support of its major shareholders and lenders to continue to advance the approvals for the Medcalf Project (refer to ASX announcements dated 16 June 2020 – Funding Update, 29 July 2019 – Update on Loan Facilities and 16 March 2018 – Update on Funding).
