Answer:

No, as previously noted, the level of net operating cash outflows going forward has reduced significantly as a result of:

- Temporary cessation of production
- Material reduction in the size of work force
- Reduction of salaries of continuing employees
- Reorganisation of the Company's corporate activities
- Accessing Federal Government stimulus initiatives

- Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer:

On 2 June 2020 the Company announced an equity raising consisting of a placement, conditional placement and share purchase plan for a total of A\$3 million. The conditional placement raising \$1.35 million is subject to approval of shareholders at a meeting to be convened in early September 2020.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer:

Yes, on the basis of the reduced cash outflows and expected cash inflows.

The Company has settled on a strategy to maximise progress with a significantly reduced cash outflow. The focus at this time is on continued exploration and expanding the mineral resource in conjunction with progressing the definitive feasibility study for development of large scale mining and processing operation. This is achievable with materially lower cash outflows than prior quarters.
