OPERATIONS UPDATE

Orminex Limited ('Orminex' or 'the Company'; ASX: ONX) provides the following update on its Comet Vale gold project (51% ONX; 49% Sand Queen Gold Mines Pty Ltd) ('Comet Vale') located in the Goldfields region of Western Australia.

Processing Update

The Board is pleased to announce that the latest processing campaign (Toll 9) was completed on the 15 July 2020 and has now been reconciled as follows;

- 5,254 ounces of gold recovered
- 33,553 dry metric tonnes of ore processed
- 5.09 g/t reconciled feed grade
- 96% reconciled gold recovery

Given the positive processing campaign results Mineral Ventures Pty Ltd has advised that it will be in a position to make a working capital repayment in excess of the \$200,000 monthly repayment for August, which continues to support the operating cash flow needs of the business.

Operations Update

The production of 5,254 ounces from the Toll 9 milling campaign is a positive outcome and represents a significant improvement relative to previous campaigns due primarily to the intersection of a 3m to 5m wide zone of ore at the northern extent of the 4.6 level development and the positive results from the improvements and optimisation around stope drill and blast practices at Comet Vale. The veining appears more complex structurally than that encountered to the south and which was not indicated in any of the historical drilling.

In order to confirm the continuity of mineralisation down dip from the 4.6 level and confirm the down dip extensions of the shoots to the south below, a 5.3 level a diamond drill program has been designed and will be completed in the coming months. The aim of the program is to confirm the continuity of the high grade and wide zones of mineralisation immediately below the current mine development.




Figure 2 Long section looking East with designed holes in blue.
