SECTION 708A CLEANSING NOTICE AND APPENDIX 2A

This notice is given by Zelira Therapeutics Ltd (**Zelira or the Company**) (ASX: ZLD) under Section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**).

The Company hereby confirms that:

1. On 11 August 2020, the Company issued 174,987,560 Shares at an issue price of \$0.05 (5 cents) per Share to sophisticated and professional investors, to raise \$8,749,378, before costs, pursuant to the capital raising announced to ASX on 3 August 2020; and
