European Metals Holdings Limited (“**European Metals**” or “**the Company**”) (ASX & AIM: EMH, FSE: E861.F) advises that it has issued and allotted 3,000,000 CDIs upon the exercise of 3,000,000 unquoted options exercisable at 16.6 cents exercisable on or before 17 August 2020. The option conversion raised \$498,000.
