



SECTION 708A NOTICE - SHARE ISSUE

Alice Queen Limited (ASX:AQX)(Company) is pleased to announce the allotment and issue on 27 August 2020 of 159,090,909 fully paid ordinary shares at an issue price of \$0.044 (4.4 cents) per share (Securities) via a placement to a range of institutional and sophisticated investors to raise a total of \$7,000,000 (before costs).
