## Cleansing Notice / Appendix 2A

European Metals Holdings Limited (“**European Metals**” or “**the Company**”) (ASX & AIM: EMH, FSE: E861.F) advises that it has completed the issue of 927,300 CDIs in respect to the second draw down of the Fund Facility Agreement between 6466 Investments Pty Ltd and European Metals.
