## **Cleansing Statement**

## Notice under Section 708A of the Corporations Act

Ardiden Limited (ABN 82 110 884 252) (ASX:ADV) (**Company**) advises that further to shareholder approval received on 27 August 2020 for the issue of 8,333,333 fully paid ordinary shares to Directors participating in the Placement previously announced on 15 July 2020, the shares have now been allotted. The ordinary shares were issued at an issue price of \$0.012 each and raised a total of \$100,000.

Secondary Trading Exemption:

The Corporations Act 2001 (Cth) (the "Act") restricts the on-sale of securities issued or transferred without disclosure, unless the sale is exempt under section 708 or 708A of the Act.
