# SSR Mining Inc. (ASX: SSR) – Commencement of Official Quotation – Foreign Exempt Listing, Deferred Settlement Trading

#### **Description**

Following approval by the Supreme Court of Yukon on 20 July 2020 of the Plan of Arrangement involving SSR Mining Inc. ('SSR'), Alacer Gold Corp. ('AQG') and the shareholders of AQG in order to effect the acquisition by SSR of AQG, it is anticipated that SSR will be admitted to the Official List of ASX Limited ('ASX') as an ASX Foreign Exempt Listing on the morning of Thursday, 17 September 2020.

As an ASX Foreign Exempt Listing, SSR is primarily regulated by the listing rules of its home exchange (being the Toronto Stock Exchange) and is exempt from complying with most of ASX's Listing Rules.

Official Quotation of SSR's CHESS Depository Interests ('CDIs') representing fully paid ordinary shares at a ratio of 1 for 1 is expected to commence at 12:00pm (AEST) on Thursday, 17 September 2020 initially on a <u>deferred</u> settlement basis.

No funds were raised by SSR in conjunction with its listing on the ASX.
