For the avoidance of doubt, the Company confirms that investors who elect to view the Meeting virtually will not be taken to be in attendance at the Meeting and will not able to participate in or vote on resolutions at the Meeting. Accordingly, if those Shareholders wish to vote on the resolutions they will need to complete and submit a proxy form on or before 10:00am (AWST) on Monday 19 October 2020.
