**Issue of Securities**

**Pursuit Minerals Limited (ASX:PUR)** ("Pursuit" or the "Company") is pleased to advise the Company has moved to allotment of the following securities in accordance with Shareholder Approval on 14 September 2020:

1. 67,375,000 fully paid ordinary shares in accordance with Resolutions 5-9; and
2. 59,000,000 unlisted options in accordance with Resolutions 11-14.

In addition, the Company has allotted 5,000,000 unlisted options on the same terms and conditions as the unlisted options above to an engineering consultant as per the announcement dated 17 July 2020 and in accordance with the Incentive Option Plan adopted 14 September 2020 with Exception 13 in ASX Listing Rule 7.1 (and therefore do not reduce the Company securities fall under the Company's 7.1 capacity).

**Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001**

The Corporations Act 2001 ("Act") restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A of the Act. By giving this notice, the shares issued pursuant to the Placement ("Shares") and noted in the attached Appendix 2A will fall within the exemption in section 708A(5) of the Act.

Pursuant to section 708A(5)(e) of the Corporations Act 2001 (Cth) ("Corporations Act"), the Company gives notice that:

- a) the Company issued the Shares without disclosure under Part 6D.2 of the Corporations Act; and
- b) as at the date of this notice, the Company has complied with the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and section 674 of the Corporations Act; and
- c) Other than as set out in this notice, as at the date of this notice there is no information:
  - i. that has been excluded from a continuous disclosure notice in accordance with the Listing Rules; and
  - ii. that investors and their professional advisors would reasonably require for the purpose of making an informed assessment of:
    - a. The assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
    - b. The rights and liabilities attaching to the Securities.

The Company notes that it is constantly reviewing new opportunities to acquire or joint venture on resource projects on a regular basis. As at the date of this notice, there is no information to disclose in relation to this ongoing process as required by Section 708A(5)(e) of the Corporations Act.

An Appendix 2A is attached which refers to the Appendix 3B's lodged on 17 July 2020 and 29 July 2020. This Appendix 2A confirms the second tranche of shares as 60,500,000 in respect of the 3B dated 17 July 2020.
