



# **Placement Completion**

Comet Resources Ltd (Comet or the Company) (ASX:CRL) is pleased to announce it has completed the first tranche of its placement of 100,000,000 fully paid ordinary shares (Shares)(Placement) at a price of \$0.02 per share to raise \$2,000,000 before costs. The Company today issued 98,500,000 Shares under the Placement to raise \$1,970,000 pursuant to its placement capacity under ASX Listing Rules 7.1 (59,100,000 Shares) and 7.1A (39,400,000 Shares). The remaining 1,500,000 Shares in excess of the Company's current 7.1 and 7.1A capacity will be issued either at the completion of the SPP, should the amount of shares issued under the SPP provide the increased 7.1 and 7.1A capacity to do so, or upon receiving shareholder approval at the Company's forthcoming Annual General Meeting.

The shares are issued under the Company's current capacity pursuant to ASX Listing Rule 7.1 (59,100,000 Shares) and 7.1A (39,400,000 Shares). These Shares will be issued at a price of A\$0.02 per share which represents:

- A 10% discount to the closing price on 2 September 2020, the last trading day prior to announcement of the Placement of Comet shares of \$0.022; and
- A 13.8% discount to the 15-day trading Volume Weighted Average Price (VWAP) of the Shares on the date of issue, being \$0.0228.
