The Company released a Scoping Study which outlined an initial potential 7-year mine life, with a strong IRR (51% post Tax), rapid payback (1.75 year) and LOM AISC of US\$776 / oz Au (ASX announcement 6 May 2020). The Company has commenced a 12,000m drill program targeting brownfield expansion and greenfields exploration.
