#### NRW Holdings Limited (ASX: NWH) - Request for trading halt

Pursuant to Listing Rule 17.1, NRW Holdings Limited ACN 118 300 217 (NRW) requests that the Australian Securities Exchange (ASX) grant a trading halt in NRW's ordinary shares with immediate effect.

For the purposes of Listing Rule 17.1, NRW provides the following information:

- a) NRW is seeking the trading halt pending the decision by the Federal Court of Australia in respect of proceedings brought by Harbrok (Dalgaranga) Pty Ltd against Gascoyne Resources Limited (subject to a Deed of Company Arrangement). See the NRW ASX announcement dated 6 August 2020, together with the announcements of 18 and 25 June
- b) NRW requests that the trading halt last until the earlier of NRW making an announcement to the market about the update or the commencement of normal trading on Thursday 1 October 2020.
- c) NRW is not aware of any reason why the trading halt should not be granted, or of any other information available at this stage that is relevant to the trading halt.
