INTRODUCTION

Sovereign Metals Limited (**Sovereign** or **Company**) and the entities it controls believe corporate governance is important for the Company in conducting its business activities

The Board has adopted a suite of charters and key corporate governance documents which articulate the policies and procedures followed by Sovereign.

These documents are available in the Corporate Governance section of the Company's website, www.sovereignmetals.com.au/corporate-governance. These documents are reviewed at least annually to address any changes in governance practices and the law.

This Corporate Governance Statement (**Statement**), which is current as at 30 June 2020 and has been approved by the Company's Board, explains how Sovereign complies with the ASX Corporate Governance Council's 'Corporate Governance Principles and Recommendations – 3rd Edition' published on 27 March 2014 (**ASX Principles and Recommendations**), in relation to the year ended 30 June 2020.
