Appointment of New Non-Executive Director

Chairman Succession

Current director, Mr Geoff Baker, will succeed Mr Edwards as Chairman upon his resignation. In preparation for this transition, Mr Baker has retired from executive duties effective 1 October. This follows the successful transition of Mike Sutton into the role of CEO and David Greig to the role of COO earlier this year.
