# Admission of shares

Pensana Rare Earths Plc (LSE:PRE ; ASX:PM8) (the "Company") announces that the London Stock Exchange has today admitted 13,500,000 New Ordinary Shares to the Official List and is trading on the London Stock Exchange ("LSE"). The issue relates to the issue of shares to the Fundo Soberano de Angola ("FSDEA"), as announced on 25 September 2020 to raise approximately US\$8.6 million.

These shares rank pari passu with the existing Ordinary Shares in issue.

Following this issue, the Company's issued share capital consists of 203,095,822 Ordinary Shares. No shares are held in treasury. Therefore, the total number of voting rights of the Company is 203,095,822.

The above figure may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change in their interest in, the Company under the Financial Conduct Authority's Disclosure and Transparency Rules.

Application is also be made for the admission of these shares to the Australian Securities Exchange.
