SHALLOW HIGH GRADE GOLD ZONES CONFIRMED AT VIPER PROSPECT

HIGHLIGHTS

- > Shallow high grade gold zones at Viper Prospect confirmed in detailed analysis of recently drilled Aircore intervals.
- Significant results include;
 - o 7m @ 9.51g/t Au from surface
 - o 7m @ 2.74g/t Au from 7m
 - o 7m @ 2.30g/t Au from 25m
 - o 12m @ 1.34g/t Au from 24m
 - o 7m @ 1.12g/t Au from 31m (EOH)
- Sampling results provide further support for subsequent phases of drilling to determine the scope for open-pit mineable gold resources at Viper Prospect.
- Further results due shortly from RC holes drilled adjacent to these highly significant new assay results.

Birimian Gold Limited (ASX:BGS) ("Birimian Gold" or the "Company") is pleased to advise that it has received final analytical results from samples submitted to the laboratory as part of a detailed resampling program of recent Aircore (AC) drill intervals at the Massigui Gold Project in southern Mali.




Figure 1. Ntiola District. Prospect locations are shown over the arsenic in soil image.

These new results significantly upgrade the previously reported drill results (See ASX Release: *Stacked Gold Trends Confirmed at Viper Prospect*, 6 November 2014) and further confirm the presence of high grade gold mineralisation at Viper Prospect (Figure 1).

Reconnaissance AC drilling conducted by the Company in October 2014 was initially sampled in 4m composited intervals. Analysis of these samples defined multiple shallow ore-grade drill intersections over significant down-hole widths, including;

- 8m @ 2.92 g/t Au from surface
- 8m @ 2.98 g/t Au from 8m, within 16m @ 1.68 g/t Au
- 8m @ 1.64 g/t Au from 24m
- 18m @ 1.05 g/t Au from 24m
- 8m @ 1.02 g/t Au from 12m

To enable the Company to further refine the spatial distribution of mineralisation and improve the geological interpretation of the target zones, a resampling program was initiated. This program involved collecting representative samples from each of the original one metre drill intervals that formed the initial gold bearing four metre composite samples. To ensure the integrity of the drill samples the original one metre drill intervals were securely stored on site during drilling operations.

Analytical results from the one metre sample intervals confirm the presence of high grade gold mineralisation over robust widths at Viper Prospect. Results are presented in Table 1. Highlights include;

- 7m @ 9.51g/t Au from surface
- 7m @ 2.74g/t Au from 7m
- 7m @ 2.30g/t Au from 25m

- 12m @ 1.34g/t Au from 24m
- 7m @ 1.12g/t Au from 31m (EOH)




Figure 2. Viper Prospect. Updated Aircore (AC) drill intersections and RC drill hole locations (assays pending)

The mineralised intervals delineated from the new data are substantially higher grade overall and more tightly defined by the detailed sampling. The results demonstrate that significant high grade gold zones are present within the more broadly defined and relatively sparsely drilled 1.2km long Viper gold trend (Figure 2)

The Company recently completed its first phase of Reverse Circulation (RC) drilling at Viper Prospect. This drilling was designed to investigate mineralised extensions at depth and along strike from the recent shallow ore grade intersections in AC drilling; including zones which are adjacent to the new results reported here.

The Company anticipates that final analytical results from the RC drilling program will be available by month end and will use this data to target further mineralisation in future ore definition drilling activities.

Birimian Gold holds substantial interests in several highly prospective gold projects situated within the Birimian Gold Belt of West Africa; a gold rich region which has produced in excess of 250 million ounces of gold from large, low cost mines. The Company's primary assets include the advanced Massigui Gold Project and Dankassa Gold Project in Southern Mali, and the Basawa Gold Project in Liberia.
