



For the last 12 years has been the Field Operations Manager for Sipa Resources Limited. He is currently based in Kitgum, central north Uganda.




Tara Robson - Company Secretary - CFO

East Africa-new frontier for Oil and Minerals

- Uganda is a part of the emerging East African Investment Story.
- New Oil Field discovered 2006, by Tullow plc. Found 1.7 Billion barrels. Sold to Total for \$US2.9B in 2012.
- New investment in minerals as a result of World Bank/Nordic Bank funded Consortium with new geological data sets and mineral potential information finalised 2012.
- Highly prospective geology on margin of Congo super-craton.
- Peace in northern regions means exploration is possible, investment is welcomed and encouraged.






Uganda-fast growing economy in East Africa

- Political and social stability re-established after turbulent decades, mid 2000s
- Mining was 30% of export earnings (50s and 60s) Sn, Cu, Co, Au
- New mineral Act 2001, clear and enforceable
- Fiscal regime attractive
 - Variable income tax rate based on profitability 25-40%
 - 3% gross value royalty (negotiable)
 - No ring fencing
 - 100% ownership possible






Highlights


- 27 shallow holes drilled 500m x 150m anomalous Zn zone
- LMC010 intersected 5m at 2% Zn EOH (1)
- Open in all directions
- Zn-Pb-Ag Cd Mn proves
 BHType Association



- 9 shallow holes define 500m long mineralised intrusive system
- Most open at depth like LMR022 55m @ 0.52% Ni and 0.15% Cu. (2)
- Sulphides are Ni rich pyrrhotite and pentlandite




Sipa's Program Timeline





Geological Setting of Kitgum-Pader Prospects

- Located on the reworked NE dipping NE margin of the Archaean Congo Supercraton
- Multiple rifting & inversion during Palaeo and MesoProt with W. Karamoja Gp sediments thrust from northeast during Pan African orogeny (~700Ma)
- Prospects include Broken Hill
 Type Pb, Zn, Ag at Pamwa
- Intrusive Related Ni-Cu sulphides "chonolith" related ie Norilsk, Voiseys Bay
- Archean/Prot greenstone hosted Ni deposits
- Orogenic shear hosted gold





Broken Hill Type Deposits - Global

- Typically high grade low pressure metamorphic terranes with restricted global distribution
- Rifted craton margins
- Mineral association Pb-Zn-Ag-Cd-Mn and are world class to giants (world class = >12Mt >8%
 Zn+Pb)



Broken Hill (Australia)	180Mt	11% Zn; 14% Pb, 200g/t Ag
Zinkgruvan (Sweden)	40Mt	6-10% Zn; 1.5-4.5% Pb, 45-100g/t Ag
Gamsberg (South Africa)	143Mt	7.4% Zn; 0.6% Pb, 3g/t Ag



Zinc Discovery July 2014


- RC drilling returned intercepts of: (1)
 - LMC10 5m @ 2% Zn
 0.2% Pb 2.4g/t Ag and 97ppm
 Cd from 20-25m EOH.
 - LMC004 38m @ 0.12% Zn EOH
 - LMC014 15m @ 0.11% Zn EOH
- Geochemical association is Zn Pb Cd Mn confirming a Broken Hill Type signature.
- The mineralization occurs in quartz-biotite schist +-garnet







Nickel Copper Discovery June 2014

- 1st pass RAB drilling returned intercepts of: (1)
 - LMR022 55m @ 0.52% Ni 0.15%
 Cu EOH
 - LMR003 46m @ 0.45% Ni and 0.15% Cu EOH
- Ni Cu sulphide system defined over 300m long by 100m wide open in all directions










Akelikongo Ni Cu Sulphides




